SUMMER SCHOOL IN ENVIRONMENTAL LAW (BRAZIL/AUSTRALIA) SUBMISSION REQUIREMENTS

Please read the following instructions carefully. The fulfillment of all these requirements is an essential condition for the approval of the article.

1. Subject content

The articles must be original, with a central legal focus and, when pertinent and possible, approach to other areas of knowledge, being able to be in one of the following thematic main points:

- 1. Fundamental principles of the Rule of Ecological Law;
- 2. Environmental responsibility;
- 3. Environmental justice: setbacks and outlooks;
- 4. Advances and setbacks within Brazilian environmental jurisprudence;
- 5. Urban policy, cultural heritage and sustainable cities;
- 6. Management of impacting activities, environmental licensing, compensation and sustainability;
- 7. Climate Change, Sustainable Development Goals (SDG) and the outlooks of the Paris Agreement;
- 8. Law and Economics, economic instruments and environmental management;
- 9. International Environmental Law;
- 10. Food security, sustainable production, renewable energy and solid waste;
- 11. Complexity, dialogue of knowledge and biological diversity.

2. Format and Style

- 2.1 The texts **must be written in English** and have a length of about 13 to 20 pages (including footnotes and bibliographical references).
- 2.2 The texts must be typed in Microsoft Word for Windows, respecting the following dimensions: A4 format, theme font Times New Roman; font size 12, spacing of 1.5 cm between lines. Top margin of 3.0 cm, bottom of 2.0cm, right of 2.0cm and left of 3.0cm.

The use of colored photos or graphics is allowed. It is not necessary to put an endpoint after titles, subheadings, authors' names and positions.

- 2.3 Bibliographical references must be made in the author-date system (Harvard). Footnotes must be used for explanatory content. Full references should be included at the end of the text in an item entitled "References".
- 2.4 The Organizing Committee of the event will not be held responsible for the originality of the articles presented, as well as for the possible lack of indication of the authors' names and the origin of the works cited in the articles.

2.5 Structure of the first page:

- a) centralized title in the first line, with capital letters, size 15, in bold. The title of the article should be directly related to the connected conclusions, especially with the main conclusion.
- b) two lines below, the author's name, centralized, with capital letters, size 13, using italics and bold. In the line immediately below, write your institution and / or position, not exceeding two lines. Leave a blank line and repeat the procedure if there are other authors.

2.6 Body of the article:

- a) Place the section titles on the left, in bold. Use Arabic numerals. Skip a line between each section.
- b) In the text and the footnotes, it is not allowed the use of bold and underlined. It is only possible the use of italic type, but not in the footnotes, moderately, to highlight some expressions.

2.7 Citation:

In the body of the article, citations must be highlighted with quotes from up to 3 lines; if more than 3 lines, citation must be highlighted with a 4 cm retreat paragraph, font size 11 and spacing of 1.5 cm between lines (without the quotes). The signaling "[...]" must be used when the citation does not start from the beginning of the sentence and/or finish before the final. As far as possible, it must be avoided long citations, except when absolutely essential to the reasoning development. In addition, it must be avoided citations of secondary sources ("apud").

2.8 Numeration

a) The section numeration must be Arabic, following this formatting:

1. 1.1 1.1.1

- b) Place dot and not hyphen between the number and the section title, giving a space between the dot and the title or subtitle.
- c) Titles and subtitles must not be followed by dot (.) or colon (:).
- 2.9 Connected Conclusions
- a) Articles without connected conclusions will be rejected without further consideration.
- b) The connected conclusions should:
- Be short, clear, straightforward, directly linked to the title of the article, and numbered, with Arabic numerals, systematized so as to allow easy comprehension, organized discussion and voting.
- Be numbered following the sequence of titles;
- Be limited to the number of 05 (five), save exceptional cases;
- Be composed, each one of them, of a single paragraph, preferably with a maximum of 3-4 lines, containing a key idea. Conclusions with more than 04 lines should be subdivided;
- Avoid truisms, so as not to contain widely accepted facts (e.g. "The Amazon rainforest has been suffering from an ongoing process of deforestation"). Nor should they contain the transcription of legal mechanisms, except when essential to the following conclusions; and
- Be straight and personal, without authors' citation or footnotes; its foundations must be written explicitly in the body of the article.

3. Submission

- 3.1 The articles must be sent to the email **summerschoolufsc@gmail.com**. It will be send an email confirming receipt. If this confirmation is not received, the candidate must send an email to gpda.ambiental@gmail.com.
- 3.2 The author(s) name(s) and the article title must be in the Subject tab of the email.
- 3.3 The email body text must contain the following information:
- a) Author`(s) name(s);
- b) Article title;

- c) Subject content (item 1);
- d) Residential or professional address and phone number.

4. Deadline

The deadline for the submission of the articles is on October 15th, 2017 at 11:59 p.m. The deadline control will be done through the date of the effective sending of the email.

5. Selection and divulgation

- a) The articles will be examined by an Evaluation Commission and the divulgation of the selected articles will be available on the website www.gpda.ufsc.br by October 30, 2017.
- b) The articles will only be admitted after the selection by the Evaluation Commission and the divulgation on the website.

6. Criteria for selection of articles

- 6.1 The main criterion is the general quality of the article, specially, the theoretical-practical importance, the bibliographical richness and the originality.
- 6.2 Articles about aspects or subjects little studied by the doctrine, as well as those of high complexity, in which there is divergence between several authors and the jurisprudence, will have preference.
- 6.3 Specific subjects will have preference over general ones, although these might be object of articles.
- 6.4 Each article can have a maximum of 3 (three) co-authors.
- 6.5 Each author can send at most 2 (two) articles, individual or in co-authoring, as long as the articles contain different themes. In the case of submission of more than two articles from the same author, it will be considered just the first two sent by email.

7. The following methodological errors will not be accepted, under penalty of elimination:

- 7.1 Articles containing only copies of citations, with minimal author's personal contribution.
- 7.2 Incompatible articles with the formatting requirements.

- 7.3 Exhibitions, which content does not respect the field delimited by the title, boarding subjects and discussions not connected straightly with the title or the articulated conclusions.
- 7.4 Articles without conclusions or with conclusions not articulated, ambiguous, long-winded or not connected straightly with the title.
- 7.5 Articles that do not contain bibliographical references.
- 7.6 Articles with imperfect orthography or far-fetched writing style. Before sending your article, do a complete grammatical and stylistic revision. These mistakes very often preclude the selection of articles with excellent content and conclusions.

8. Presentation of the articles

- 8.1 The presentation of the articles will be on **December 01, 2017**, in the afternoon and the evening.
- 8.2 The presentation will be done orally, in English or Portuguese, without the use of audiovisual equipment.
- 8.3 Personal representative designation will not be allowed for the oral presentation of the article.
- 8.4 For the publication, it is necessary that, at least, one co-author present the article. However, the presentation certificate will only be given to the co-author who attend the event and present the article.
- 8.5 During the presentation, the participants will be able to present exclusively suppressive corrections, without admitting modifying corrections.
- 8.6 After the presentation, there will be discussions for five minutes;
- 8.7 Subsequently, the author will have five more minutes to reply;
- 8.8 In the sequence, the article will be voted. Only the articulated conclusions will be voted, in group appreciation, if there is no distinction to any of them. In case of distinction, the articulated conclusions will be voted one by one. The article with 50% plus one of the present votes will be approved.
- 8.9 There will not be change of date or place for the presentation of the article in any circumstance.
